ACTON ITEM: ADOPTION OF NEW SCHOOL MASCOT RESOLUTION

Motion made by Ms. Lynch and seconded by Mrs. Northup-Lynch to approve the New School Mascot Resolution;

WHEREAS, the West Canada Valley Central School District Board of Education has been required to modify its mascot by the State of New York as to abandon any reference to indigenous people; and

WHEREAS, the District, in an effort to find a new mascot, has requested input from stakeholders within the District, including community members, students, and staff, through use of an informal poll vote of certain pre-selected mascots (Eagles, Nighthawks, Wildcats and Wolves); and

WHEREAS, to ensure the District is able to adopt and implement the new mascot as soon thereafter the informal poll as possible, the Board would like to authorize the adoption of whatever mascot is supported by the majority of the community, students and staff;

THEREFORE, BE IT RESOLVED, that the Board of Education hereby adopts the mascot as selected by the community, students, and staff, at its December 13, 2023 informal poll. As soon thereafter the vote as possible, the District is authorized to use and implement the mascot selected

DISCUSSION ITEM: BUDGET WORKSHOP I

Mr. Wheelock reviewed the Board adopted Budget Calendar and Assumptions for building the 2024-2025 school budget. The Board was also presented with the transportation plan, which included the proposed bus purchases to be included in the budget, and a copy of the 2023-2024 rate reference chart that will be up for review and adjustments as needed for the 2024-2025 school year.

DISCUSSION ITEM: CAPITAL PROJECT

Mr. Wheelock informed the Board that the District's domestic water has been renovated and is operating as normal. Renovations to the pool are complete, with the exception of locker room doors, and the District will begin filling it on December 18, 2023. Contractors will begin renovations in the auditorium over the holiday break and should be completed by January 31, 2024.

DISCUSSION ITEM: MASCOT UPDATE

Mr. Wheelock informed the Board that the advisory poll for the new mascot selection will take place on December 13, 2023 from 12:00PM-8:00PM for eligible voters who reside in the district and students and staff will make their selections during the school day on the 13^{th} . There will be a mascot reveal pep rally at the end of the school day on December 15, 2023. The Board of Education is welcome to attend the pep rally.
